Fees and Billing

Issues resolved

- **Subsidies [NSW DoE]: 'Allocate to Outstanding Fees' option did not work**
Selecting the Allocate to Outstanding Fees button for a subsidy (Subsidies | Subsidies | Allocate to Outstanding Fees) did not open the Allocate Subsidy to Fees screen.
This issue affected NSW DoE schools only.

Academic Reports

Issues resolved

- **Text component: Text used for hyperlinks was not being respected, with URL code printed instead**
System logic has been updated to allow more special characters such as '?' and '=' when adding a URL.
- **Generating academic reports when a large number of Student flags existed would result in a performance issue**
- **The graphs in the My Class Status section were displaying as line graphs instead of bar graphs**

Activities

Issues resolved

- **When adding new step in an approval workflow, it was added incorrectly after the last step**
The first and last steps in the activity approval workflow are auto-generated and do not require approval. Any approval step added to the workflow must fall in between first and last steps with an option to change the approval order.
- **'Approval Required' setting set to 'No' was not being respected, resulting in activity self-registration not being automatically approved**
The registration status was still showing 'Pending' in the activity participants list instead of 'Approved'.

Analysis

Issues resolved

- **After a school had imported files under the NAPLAN VIC file type, new year groups were being created**
To address this, the new year groups are now converted to existing school years when importing
- **VIC: Naplan band data was not imported if split over multiple files for the same year group**

Attendance

Issues resolved

- **The list of approved future absence notifications was unable to be viewed in some circumstances**
School Attendance | Notification | Future Absence Requests | Approved
- **Partial absences page pagination was displaying incorrect results after page 1**
- **The STATS report export was not printing any data when the option to 'Restrict to standard STATS Year groups' was selected**
A new option has been added in the STATS export to use the Census Year from enrolments instead of the Year Level Code.
- **Absence reasons were not displaying in the future absences table**
A new endpoint to expose future absence reasons has been added to the API.
- **An error occurred when attempting to add a comment to a student's absence via the student Attendance History view**
- **Roll display was showing a student as available for marking one day before their start date**
- **Disabled rolls were showing in the 'My unsubmitted rolls' list**
- **The count of year-to-date absences on a student's attendance screen was incorrectly including future absences**
- **Part time schedules set up in Enrolments were not being respected on rolls**

Attendance PxP

Issues resolved

- **Multiperiod absence time selection was only displaying the times of the second period, preventing a partial absence from being added in the first period**
Maximum Timed Absence setting in Settings screen can be set to 'Period Time', which will allow period times to display for the entire length of the period. In the case of Multiperiod absences, the user will now see period times for both periods.
- **Disabling classes would cause an error if the count was too high**

Core\Data Sync

Improvements

- **Data Sync: The SAIS data sync credentials have been restricted to read-only access for schools using the SAIS data source**
NSW DoE schools who believe the sync credentials are incorrect should contact Sentral for assistance.

Enrolments

Issues resolved

- **Student Code: An error occurred when attempting to change the Student Code Algorithm setting in Enrolments | Setup Enrolments | School Settings**
- **Houses: An incorrect house was shown against a student due to the system looking up the student's future enrolment record instead of the current enrolment record**
- **Students: Certain student's summary screen showed an incorrect enrolment type against the sibling record attached to the same household**
Added ability to link a custom enrolment status to an inbuilt status via Enrolments | Setup Enrolments | Enrolment Statuses | Edit. The linking will ensure that the system is able to correctly display the correct enrolment type for students placed on a custom enrolment status.
- **Flags: The Custody Arrangement automatic flag was not always applied or removed when a student's household Residential Status changed**

Health

Issues resolved

- **Ambulance Report:** The ambulance report PDF failed to generate for certain students with a linked Emergency Care Plan

Issue Tracking

Improvements

- **Widget:** Updated the Task Statistics widget to display data specific to the logged in user, including filtering for tasks assigned to and created by the user

Issues resolved

- **Reports:** For certain task types, the Task Details PDF Report failed to print any tasks in relation to the task type

Markbook

Issues resolved

- **Classes from non-selected year levels** were displayed on the distribution plot for calculated columns

Student Profiles

Issues resolved

- **Flags:** Flags assigned to certain students were showing duplicates in the students' profiles

Timetables

Issues resolved

- **Events coming through from Edval Daily** were appearing on teacher timetables but not on the associated room timetables

Wellbeing

Issues resolved

- **Long load times** were experienced when viewing students in Wellbeing with an incident history that included multiple students
- **Restrictions on awards** were able to be bypassed by going to the specific student and then adding the award
- **NSW DoE schools:** The total days suspended on a student's suspension screen was displaying incorrectly for some students
- **NSW DoE schools:** An overlapping suspension error was appearing when a suspension in a year prior to 2024 had no expiry date
Suspension overlap rules will only apply from the start of 2024 when the new policy was introduced.
- **NSW DoE:** Suspensions requiring adjustment from pre 2024 were not able to be edited or resolved
- **NSW DoE schools:** Editing a suspension from the student screen was not sending an update to the DoE
- **NSW DoE schools:** Formal Cautions were included in the Expired Suspensions count
